Ed Veerman queried why the Crown footpath was still closed. Cllr Sinkins reported on an email received from Cormac (James Clapp) reporting that the path would remain closed until August while they try to find the source of the contamination. Ed considered that this response was unreasonable, given the health risks posed by sewage escaping into a public area. Cllr Turner noted that, whilst the footpath was supposed to be closed, people were still using it. Cllr Sinkins assured the meeting that she would continue to try to get the situation resolved and hopefully Cllr Martin would also press for an urgent resolution.

## **17/162 Planning**

PA18/01771. Partial retention of existing building and construction of an additional unit of holiday accommodation with the footprint of former cottages. Land north east of Rock Mill, Prideaux. It was noted that this application was the outcome of an enforcement investigation as the site had been developed contrary to planning approval granted in 2012. Cllr Sinkins concluded that the new plans were largely in line with the previously approved 2012 designs but the parking provision was now alongside the building, a 27 step escape route had been added and there was no provision for the removal of the illegal battery house. It was proposed by Cllr Sinkins, seconded Cllr Richards and RESOLVED that a recommendation of no objection should be made to Cornwall Council but providing that conditions were attached 1. The new parking area must have adequate screening 2. The illegal opening on to the highway must be closed up and the concrete hard standing removed 3. The battery house must be demolished.

Cllr Richards asked if the parish council would finance some paint for the Sweetshouse bus shelter. This was agreed.

Cllr Turner queried why the school was replacing natural slate on the school roof with ugly composite tiles. As the building was adjacent to the listed Church it was agreed that this should be reported to planning enforcement for investigation

Cllr Sinkins reported bad potholes in Loving Lane and the road from Penpillick to Sandyway Cross.
