Lanlivery Parish Council proposes that the St Blazey Fowey Lostwithiel Community Network Group consider including within their Highways Scheme a 40mph speed limit zone to be put in place on the A390 from the top of Lostwithiel Hill, to include the junction of the B3269 to Bodmin and the B3269 to Fowey. The purpose being to improve road safety at both junctions as well as at the two minor roads to Lanlivery, all of which have a significant history of RTA's.
