Minutes of the Meeting of Lanlivery Parish Council held in the Village Hall on Wednesday 6th June 2018 at 7.00pm

18/22 Present Cllrs Sinkins, Challis, Haley, Paterson, Richards, Roberts, Turner

18/23 Apologies None

18/24 Declaration of Interests

- i. **Pecuniary** – Cllr Challis declared a pecuniary interest in the quote for the clearance of the picnic area

18/25 Public Questions

Mrs Paterson queried if the lanes in the village could be designated as ‘quiet lanes.’ It was agreed that this could be investigated, although there was some doubt that this option was still available. Cllr Martin would investigate.

Ed Veerman queried progress on the sewage spillage onto the Crown footpath. Cllr Martin assured the meeting that this was in hand, although yet to be resolved.

Ed Veerman had looked at the drawings for the proposed Roselyon School car park and noted that they showed the route to the A390 as being down towards Puddle

Ed Veerman did not support the imposition of a 40mph limit on the A390. He considered that if people thought cars were only travelling at 40mph they were more likely to take chances pulling out of the side roads thinking they had more time. Cllr Martin appreciated the point and would raise it but considered that something was needed on this very dangerous stretch of road. He confirmed that adjoining parishes in the CNA had also supported improvements at this location

It was proposed by Cllr Roberts, seconded Cllr Challis and RESOLVED that the minutes be confirmed and signed by the Chairman

- He was pleased that some potholes in the parish had been filled.

Cllr Sinkins proposed, Cllr Richards seconded and it was RESOLVED that accounts to the value of £607.25 should be approved

Cllr Richards proposed, Cllr Sinkins seconded and it was RESOLVED that the quote for the clearance of the picnic area should be accepted

Cllr Challis returned to the meeting

18/30 Resolutions from Councillors

Cllr Sinkins proposed, Cllr Richards seconded and it was RESOLVED that Lanlivery Parish Council proposes that the St Blazey Fowey Lostwithiel Community Network Group consider including within their Highways Scheme a 40mph speed limit zone to be put in place on the A390 from the top of Lostwithiel Hill, to include the junction of the B3269 to Bodmin and the B3269 to Fowey. The purpose being to improve road safety at both junctions as well as at the two minor roads to Lanlivery, all of which have a significant history of RTA's. Of additional concern, from September 2018, when the new Roselyon School opens in Lanlivery, there will be two schools operating within the village creating more traffic on the surrounding roads at peak times

18/33 Neighbourhood Plan

Cllr Sinkins reported that the Examiner had posed some questions, which had now been answered with the help of Ryan Searle from Cornwall Council.

18/34 Planning

PA18/04437. Extension of an existing informal car park to allow increased parking capacity for Churchtown to function as a school. Field Studies Centre, Churchtown Farm, road from junction of Pennant and Snow Hill to junction south of Churchtown Farm, Lanlivery. It was proposed by Cllr Paterson, seconded Cllr Haley and RESOLVED that a recommendation of no objection should be made to Cornwall Council but noting that the location details on the plans were incorrect and extremely misleading.. |

18/35 Roselyon School

Cllr Sinkins reported that, together with the Clerk, she had met William Trinnick and the Head of Roselyon School and agreed and marked out the proposed passing place, together with the informal one in the gateway. The agreed position was the one previously identified by the parish council. Mr Trinnick was now progressing the scheme with the landowner and highways.

18/36 Venue for Parish Council Meetings

Cllr Sinkins reported that the trees needed cutting back at the junction of the A390 at Fowey Cross. Cllr Martin would try to get this attended to.

Cllr Sinkins reported that the grass at the junction onto the A390 from Penpell Farm needed cutting back. Cllr Martin would try to get this attended to.
