18/67 To receive reports from the Cornwall Councillor

Cllr Martin reported

- He was investigating the legality of the new gateway access at the junction of the A390 and the road to Penpell. However, he had not realised until being told by the members that the access had previously been pedestrian and not vehicular. Consequently he would now report this to enforcement and highways.
- He queried if the pollution on the Crown Inn footpath had now been sorted out. Members responded that the path now appeared to be dry.
- He was pleased to announce that the Liberal Democrats had selected him to be their candidate at the next General Election
- Cllr Paterson noted that Kernow Veterinary Group would be up-righting the tree on the verge at Nomansland in the autumn; it was a memorial tree. Cllr Martin would advise Rachael Tatlow accordingly.
