Minutes of the Meeting of Lanlivery Parish Council held in the Village Hall on Wednesday 7th November 2018 at 7.00pm

18/93 Public Questions

Cllr Sinkins confirmed that the land purchase for the new layby had yet to be completed but the Headmistress had assured her that it would be done as soon as possible. It was noted that the planning permission expired in December.

18/94 Minutes of the Meeting held on 3rd October 2018

It was proposed by Cllr Haley, seconded Cllr Challis and RESOLVED that the minutes be confirmed and signed by the Chairman

18/95 Matters arising from the minutes not on the agenda – *for report only*

Cllr Sinkins noted that the parish council had maintained its objection to the Higher Pennant application and a member of the council would need to speak at the planning committee meeting.

18/96 To receive reports from the Cornwall Councillor

Cllr Martin reported

- He would support the parish council objections to the Higher Pennant planning application.
- Rachael Tatlow had looked at the nominated Highways Schemes but had responded negatively to Lanlivery's suggestion of lowering the speed limit to make the A390 junctions safer as a review 6/7 years ago had concluded that the current speed limits were acceptable. However, Cllr Brown, the CC portfolio holder, had been sympathetic to the proposal as he respected local opinion so he would carry on pursuing the idea.
- There would be no more money coming to Cornwall following the recent budget.

- Care workers would now get parking permits in CC car parks and be able to park sensibly on double yellow lines.
- There was growing impetus in Lostwithiel to provide a pedestrian railway bridge in and to convert some of the sidings into car parking.

18/97 Accounts for Approval

Cllr Roberts proposed, Cllr Haley seconded and it was RESOLVED that accounts to the value of £203.40 should be approved.

Electronic correspondence had been circulated. Correspondence was left ‘on the table’ for Councillors attention.

18/100 To receive reports (if any) from Parish Councillor Representatives

Thomas Bullock. Cllr Sinkins reported that the Trust had sponsored local rider Amy Richards, who had been selected for the Prime England Dressage Squad and then represented Great Britain at Le Mans in France. She had finished 6th as an individual.

Community Network. Lostwithiel would be getting a TSSO in the new year (combined fire officer, first responder and PCSO) and the officer would also cover parts of Lanlivery parish

The StARR project had now received its last £10 million funding

18/101 Neighbourhood Plan

Cllr Sinkins reported she would chase Cornwall Council for the date of the referendum.

18/102 Planning

1. PA18/09594. Side extensions to form conservatory at ground floor and first floor ensuite/storage area. Higher Greadow Cottage. It was proposed by Cllr Richards, seconded Cllr Roberts and RESOLVED that a recommendation of no objection should be made to Cornwall Council

2. PA18/00019/NDP. Plan proposal submitted for Lostwithiel Neighbourhood Development Plan. Noted.

3. PA18/00003/SPD. Cornwall Council draft Housing Supplementary Planning Document – 6 week consultation period between 19th October and 5pm 30th November 2018. It was proposed by Cllr Sinkins, seconded Cllr Haley and RESOLVED that the parish council should respond asking for more weight to be given to Neighbourhood Plans and more thought given to the locations of exceptions sites.

18/103 Traffic Calming in Lanlivery Village

A child had nearly been hit by a car outside Lanlivery school and the parent had asked the parish council if some form of traffic calming could be investigated. Members discussed various options including, *inter alia*, rumble strips, flashing 20mph signs, a triangle in the centre of the road designed to act as a roundabout, additional road markings, dragons’ teeth. It was proposed by

Cllr Sinkins, seconded Cllr Haley and RESOLVED that Cllr Martin should be asked if he could arrange for a Highways officer to visit the village to discuss possible options before taking the matter any further..

18/104 Budget 2019/2020

The Parish Clerk had provided details of expenditure to date against budget for 2018/2019 and using this information and projecting future income and expenditure, members calculated a budget for 2019/2020. Resulting from this it was proposed by Cllr Sinkins, seconded Cllr Richards and RESOLVED that the parish council should request a precept of £9484.00 for 2019/2020. The increase on 2018/2019 represented new expenditure for the playing field maintenance (devolved from Cornwall Council) and an increased donation of £200 for the Granite Towers.

18/105 To receive reports (if any) from Parish Councillors *(at the discretion of the Chairman)*

Cllr Roberts reported that she had had a near miss when entering the Penpell road from the A390. She would report to CC Planning and Highways.
