Police Report

There had been 1 recorded crime in the parish during September $-1 \times \log out$ of control causing injury and 4 logs created $-2 \times transport$, 2 x public safety. *Public Questions*

Ed Veerman queried if the parish council was still receiving an annual payment for the solar farm at Sweetshouse. The Clerk responded in the affirmative.

15/66. Cllr Jenkinson reported that she was still awaiting a report on the pipe weeping liquid on to the footpath from the Crown to Roselath 16/71. The Clerk reported that she had attended a Cornwall Council training session on the Paperless Planning initiative, which had highlighted numerous problems. However, it was clear that CC had no intention of reconsidering their decision to introduce compulsory participation from 1st April 2016. Mike Phillips had been asked to cost out a laptop, screen and projector.

- At the recent Community Network meeting it had been confirmed that EU money was available to support rural businesses; she would forward details to the Clerk
- Cllr Roberts reported that Service Standards were also discussed at the Network meeting and definitive lists would be available in February 2016

Luxulyan Valley Partnership. Cllr Sinkins reported that an initial phase of grant funding had been approved by the Heritage Lottery Fund

The correspondence list had been circulated and the correspondence was left 'on the table' for Councillors attention.

A letter had been received from Scope advising of the imminent new ownership of Churchtown Farm. The purchasers were a partnership between The Lost Gardens of Heligan and Hurst Lodge School, Ascot. Sir Tim Smit, one of the partners, had offered to meet and discuss his plans with the parish council

Cllr Turner reported that a footpath in Churchtown had been diverted many years ago. There was now an alternate permissive path in place but she was concerned that this could be blocked by the new owners, which would restrict access to the Holy Well. Cllr Turner agreed to let the Clerk have a copy of a map showing the old footpath.

Cllr Roberts reported that the Plan was progressing; at the Community Network meeting ideas for additional content had been suggested. The Clerk reported that a £500 grant was available from Cornwall Council and supplied Cllr Roberts with the details.

15/89 Criminal Records Checks for Members

Given that Cornwall Council would not fund this initiative, it was proposed by Cllr Sinkins, seconded Cllr Roberts and RESOLVED that the parish council would not be justified in undertaking the checks at the present time, but that this position should be subject to review.

Cllr Richards reported that the road at Sweetshouse had been resurfaced but at one point the drain was actually higher than the road Cllr Sinkins reported notices showing 'Uneven Road Surface' had been erected at Loving Lane and the road from Penpillick to Trethevey.
