#### **15/58 Neighbourhood Plan**

Cllr Sinkins reported that the next step in the process was to engage somebody to write the plan; she was actively investigating this at present. Cllr Haley reported that she had mistakenly been included in the questionnaire raffle and had won so the prize for the shrubs was redrawn. The winning number was 174.

Cllr Richards reported a pothole outside Pump Cottage at Boslymon.

Cllr Christophers reported potholes on the main approach road to Lanlivery village and on the road outside Nankivell.

Cllr Sinkins reported bad potholes on Lanlivery Lane and on the approach to the Sandyway Granite Cross.

Cllr Christophers reported that the hedges had been badly cut back on the Streigh side of the road between the village and Streigh Farm. Cllr Haley would speak to the farmer. It was agreed that local landowners should be respectfully reminded to cut their road hedges back.
