#### 13/188 Provision of a Defibrillator for Lanlivery

Natalie Phillips gave a presentation on her involvement with the Ronnie Richards Memorial Charity and the provision on defibrillators in Lostwithiel and confirmed that she would be more than happy to assist Lanlivery if the parish council wished to secure one -full report appendix7.

#### 13/189 Public Questions

Some concern was voiced that if a defibrillator was located in the village it would not help outlying parishioners. However, it was agreed that the village would be the obvious place to site one as it was relatively central and the highest percentage of people would benefit, including the school. It was agreed that Cllr Richards would invite the FLEET representative to the May council meeting before any final decisions were taken. Cllr Bay indicated that she would look favourably on an application to her Community Chest for funding and would send an application form to the Clerk.

Mike Haley advised that the aqueduct in the valley had leaked before; the excessive rain that had been experienced during the winter may have aggravated the problem as had happened in 1964.

Gary Hainsworth queried where the new Neighbourhood Watch signs should be sited. It was agreed that one should be in the village and one at Sweetshouse but that a final decision should be taken at the May council meeting.

The Clerk recorded thanks from all present to the Chairman and his wife for providing wonderful refreshments before the meeting.
