12/86 Public Questions/Police Report

Ed Veerman queried a recent planning application for a barn conversion that the parish council had supported, and which had been approved by Cornwall Council with no occupancy conditions attached. Whilst he was not necessarily against this he asked if this was a material change from former policy. Members responded that this did appear to be the case.

Mr Worth explained his current application for a garage had been submitted while he was waiting for the result of another application incorporating a garage and holiday accommodation over, which was awaiting an appeal decision.

Mr Hicklin reminded drivers to be aware of winter driving conditions – low sun and muddy, leafy roads - when using the roads in the parish.

Mrs Hicklin was concerned about the lack of information available to potential voters about the candidates standing as the new Police & Crime Commissioners

Sarah Furniss had attended to represent the owner of an adjacent property in respect of application PA12/08987. The property was about 458 metres from the proposed site and the house was a listed building. Jill, the owner, had high-class mares and foals on her property and considered that the proposed turbine would have an extremely detrimental impact on both her property and her business.

- The leader of Cornwall Council had been removed by a vote of no confidence and had been replaced by Cllr Jim Currie. As a result the controversial issue of shared services had been put on the 'back burner' until after the May election. The new Cabinet had met for the first time earlier in the day.
- She was following up on the issue of the surface of the village play area, which had reached the end of its useful life
- Cllr Hughes reminded Cllr Bain of the need for repairs to the road leading to Treganoon
- Cllr Haley reported that repairs were needed to the Redmoor road, at the junction to Chark.
- The stationing of caravans and various other issues at Higher Pennant had been reported to planning enforcement by neighbours
- Cllr Bain would check the position with regard to road salt for winter 2012/2013. Cllr Richards would also investigate the cost of restocking and report back to the Clerk
- The Core Strategy, now called the Cornwall Local Plan, would soon be out for consultation
- Cllr Bonney was concerned that dog faeces were being put in the village litter bin; he asked if dog bin could be provided

12/99 Planning

- 1. PA12/08987. Installation of a single wind turbine in a field to the north west of Trevenning Farm to generate and supply the farm with renewable energy. Trevenning Farm. It was proposed by Cllr Roberts, seconded Cllr Christophers and RESOLVED that a recommendation of objection should be made to Cornwall Council Reason: Reason: 1. Although not situated within this sensitive area, the turbine would be visible from and have an unacceptable impact on the Fowey River AONB and the Heritage Coastline. 2. The turbine would detract from Lanlivery Church, which is a grade 1 listed building and is clearly visible from large parts of the Castledore to Pelyn road. 3. Whilst the Lanlivery Parish Plan supports small-scale renewable schemes, it does not support the erection of large or commercial turbines. 4. This large turbine in such a conspicuous location would distract motorists on the adjacent narrow and winding highway. 5. The erection of a turbine of this height would create an unacceptable precedent in an area that relies heavily on tourism.
- 2. PA12/09830. Construction of a carport and garage with annexe accommodation over. Mill Beam Farmhouse. It was proposed by Cllr Richards, seconded Cllr Haley and RESOLVED that a recommendation of support should be made to Cornwall Council. *Reason: To help to secure the future of a family run farm*
