The parish photograph and the presentation of the Jubilee mugs would take place after the tea.

The Bell Tower would be open from 10am for another opportunity to ring the 'Parish Peal.'

Tim Turner would erect directional signs for the car park in the glebe field.

Parking in The Crown would be for pub customers only.

The Beacon would be lit in the 'Beacon Field at 10.15pm by Mr & Mrs Chapman. Hot soup and rolls would be available for a donation, courtesy of the Church.
