11/119 HM The Queen’s Diamond Jubilee

*Cllr Richards proposed, Cllr Haley seconded and it was **RESOLVED** that the meeting should be closed to allow Diane Williams and Lee Hemmings to speak.*

Diane Williams suggested that the Tuesday might be the most suitable day for the tea party and the photograph. However, she later revised this opinion and felt that later in the day on Monday before the beacon might be a better time. Lee Hemmings considered that commemorative mugs would be the most useful gift.

The meeting reopened.

- Cllr Hughes reported that the beacon had been registered and would be lit at 10pm on the Monday. Cllr Hughes would contact the Army Cadets, who had offered to help.

- The tea party would be held later in the day on the Monday before the beacon was lit. Cllr Richards would organise the catering for the tea party. Cllr Christophers reported that her mother had offered to run a quiz in aid of tea party funds. People would be invited to bring a plate of food. Cllr Haley would organise tablecloths, flags etc. Diane Williams would loan bedsheets for tablecloths and a marquee if required. Cllr Richards and Cllr Bonney would organise the clean-up after the tea party.
- Keith Adams had agreed to organise a village photograph on the Monday
- It was agreed that commemorative mugs would be presented to the children in the parish, with additional mugs available for sale. The school had agreed to cover the cost of a mug for any child attending the school but not living in the parish. Cllr Hughes proposed, Cllr Turner seconded and it was RESOLVED that 216 Trent mugs should be ordered.
- Cllr Richards would liaise with the bellringers about joining in the National Peal and also ringing before the tea party.
- Cllr Turner would organise parking on the day.
- Cllr Christophers would apply for the road closure.

11/120 Planning
