Minutes of a Meeting of Lanlivery Parish Council held in the Village Hall on Wednesday 7th December 2011 at 7.00pm

11/63 Public Questions/Police Report

<u>Police report</u>. The Clerk reported that there had been 1 crime (assault -detected) and 1 police log (police fail to stop) generated in November. Public Questions

Mike Dustow explained to the meeting that his son Chris was currently living in Sticker but he was hoping to be able to build a house for himself and his family on their family farm, Colwith. This could either be done under an agricultural restriction or, maybe, as an affordable home. Chris added that it would be a 3/4 bedroom basic farmhouse.

Andy Grose outlined some detail about application PA11/08575 and explained to the meeting that there would be no increase in the footprint of the existing garage, which they wanted to convert; the only visual difference would be the replacement of the garage door with patio doors.

Ed Veerman reported that there had been an accident in the village the previous week but assured the meeting that this had not been caused by vehicles parked outside the property he was developing.

11/64 Minutes of meetings of 7th September, 5th October and 2nd November 2011

7th September. Proposed by Cllr Richards, seconded Cllr Haley and RESOLVED that the minutes be confirmed and signed by the Chairman. 5th October. Proposed by Cllr Richards, seconded Cllr Bonney and RESOLVED that the minutes be confirmed and signed by the Chairman. 2nd November. Proposed by Cllr Turner, seconded Cllr Hughes and RESOLVED that the minutes be confirmed and signed by the Chairman.

11/65 Matters arising from the minutes not on the agenda – for report only

The bus shelter on the A390 was no longer in use so Cllr Roberts proposed Cllr Richards seconded and it was RESOLVED that the cleaning should be discontinued and that the Sweetshouse shelter would be renovated but no longer cleaned.

Cllr Turner reported that the drain between the Old Chapel and the village still needed clearing. Cllr Bain agreed to follow this up.

Cllr Roberts reported that Sandyway was desperately in need of attention; there were large potholes in the road, which were causing damage to vehicles. The Clerk responded that Teresa Frost (Highways) had told her the previous day that she was 'on the case.' Cllr Bain agreed to follow this up.

Cllr Hughes reported that Treganoon Lane was also in need of attention. Cllr Bain agreed to follow this up.

Cllr Roberts thanked members for attending the Remembrance Service Cllr Hughes reported that the Chapmans had agreed to have a beacon on their land for the Jubilee, although there might be a problem with parking. Lanhydrock Estates had also offered to provide wood and resources for a beacon on the top of Helman Tor.

Cllr Roberts reported that the Church had offered to provide food at the proposed beacon at the Chapmans farm

It was felt that a Jubilee street party should be a village activity and not a school activity and should be held in the street and not in the Forest Field or elsewhere in the school. Cllr Haley reported that Thomas Bullock had agreed to donate £50 towards the cost of the party.

It was agreed that the Jubilee celebrations would be an agenda item for the January meeting.

It was proposed Cllr Richards seconded Cllr Hughes and RESOLVED that the precept should remain unchanged at £5595.00
