- i. In items on the agenda Cllr Turner declared a personal interest in the acquisition of the field adjacent to the playing field as she was a school governor. Cllr Roberts declared a personal interest in the cutting arrangements at the new cemetery as he was a member of the PCC

10/74 Public Questions/Police Report

PC Lea had submitted a police report showing no crime in the parish during September – appendix 1

Keith Adams wished to record a vote of thanks to the parish council for working so hard to secure the field next to the playing field on his own behalf, on behalf of the Governors of Lanlivery School and on behalf of the schoolchildren themselves. Being able to use the land would enable Lanlivery School to achieve Forest School status, which would be a great benefit. The Chairman added that he was hopeful that farmers in the parish would work with the school and allow the children access to their farms in conjunction with this initiative, if at was at all possible.

Norman Pendray explained that he had been granted planning permission for a 5 bedroom holiday house 5 years previously and his current application was just to downsize to a 3 bedroom dwelling.

The Chairman and Clerk noted that the new Cornwall Council practice of consulting online rather than sending paper copies of plans was just not working – the authority needed to either supply a projector and the necessary laptop and software to allow parish councils to view details at meetings or return to supplying paper plans. Cllr Bain agreed to follow up on this.

10/75 Minutes of meeting of 1st September 2010

It was proposed by Cllr Bonney, seconded Cllr Turner and RESOLVED that the minutes be confirmed and signed by the Chairman.

10/76 Matters arising from the minutes not on the agenda – for report only

10/61. Cllr Richards reported that Annie Langmaid had kindly painted the Millennium Stone the previous day.

10/64. Cllr Christophers reported that Hamish Gordon had advised that the parish council was responsible for cutting the Whistow/Breney footpath as it was a Gold Path. Cllrs agreed to look into this when compiling the budget for 2011/2012.

10/64. Cllr Turner advised that balsam was an annual so should be sprayed in its infancy to prevent spreading. Cllr Bain agreed to ask Cornwall Council for control advice.

10/70. The had been no problems with cars parking inappropriately on the grass at the entrance to Thomas Bullock

- 1. Cllr Bonney noted that the roadman had removed a protruding stone from the hedge at Fowey Cross.
- 2. Cllr Turner reported that there was some water leakage across the Crown footpath.
- 3. Cllr Hughes noted that the road to Treganoon was still in bad repair. The Clerk confirmed that Highways were aware of several roads in the parish in need of attention.
- 4. Cllr Richards reported that the parish council needed to consider the demolition of the two bus shelters in the parish, which were redundant and in poor condition.

It was proposed by Cllr Richards, seconded Cllr Christophers and RESOLVED that accounts to the value of £9070.50 be approved New Churchyard: Cutting arrangements. Cllr Turner reported that only the top half of the Churchyard needed cutting, the bottom half would be left in a natural state; just topped twice a year. It was proposed by Cllr Richards, seconded Cllr Bonney and RESOLVED that the parish council would undertake the cutting of both the old and new churchyard up to the budget allowed of £600. The Clerk was instructed to contact Ed Veerman and request a cutting schedule for the work, within this budget.
