Police Report

Ed Veerman queried what had happened to the road sweeper formally used by Cormac to clean the village approximately once a month as he considered increasing accumulations of mud on the roads to be dangerous. It was agreed that Cllr Jenkinson should be asked to speak to CC Highways

The correspondence list had been circulated and the correspondence was left 'on the table' for Councillors attention.

A letter from Mrs Verna Roberts complaining about the damage to lanes from farm vehicles was read out. This was particularly bad in the lane from Penpillick to Black Hill. It was agreed to write a reminder to farmers in the Granite Towers to clear up each day and to ask Cllr Jenkinson to mention it to Highways.

15/141 Accounts for Approval

It was proposed by Cllr Richards, seconded Cllr Roberts and RESOLVED that accounts to the value of £450.39 should be approved.

15/143 Neighbourhood Plan

Cllr Sinkins reported that together with Cllr Roberts she was working on the Plan and would have an update in time for the next meeting

15/144 Community Emergency Plan

Cllr Roberts reported that she was working on the plan and would have an update for the next meeting.

15/145 Highway Issues on Approach Road to Penpell

Cllr Sinkins explained that there was an issue with parking outside Penpillick Council Houses as well as litter left by the tenants in number 2, who were constantly repairing cars on the road. Sometimes at weekends and evenings there were up to 12 cars parked when there is only technically space for 4, which was causing a significant obstruction and could prevent access for emergency vehicles.

There was also a loose tree root in the wall at the bottom of the Council House gardens, which needed attention before it brought the wall down. It was agreed to write to Ocean Housing in this regard.

15/146 To receive reports (if any) from Parish Councillors

Cllr Hughes reported a very large pothole at Redmoor, outside Rosedale. Cllr Turner reported that Loving Lane was now flooding making it almost impassable. Cllr Jenkinson was asked to report these two issues.

Cllr Richards reported a call at his home from a man purporting to be selling items on behalf of the Young Offenders Institution. He was verbally abusive when refused and was travelling on foot. Cllr Christophers agreed to pass this information to PCSO Merrikin

Cllr Haley reported that Tony Pollard had had egg money and the CCTV camera stolen from the entrance to Streigh Farm.

Cllr Roberts agreed to ask Cormac and/or Highways if there is a schedule for the Parish for maintenance of drainage ditches, roads, potholes etc. and, if so, could we know what it is so that we can plan accordingly. Cllr Sinkins reported that Keith Body had rung her to say that the lintels underneath the 3 ton bridge below Beehive Hill are cracked. Cllr Jenkinson was asked to report this to Highways.
