Clay Cowie introduced himself as the Conservative candidate standing for election to Cornwall Council in the May elections

Robbie Patterson reminded the meeting of the 'Alert System' currently being trialled and which entails the police sending out notifications to members of the community who are signed up to the system

Ed Veerman noted that he was most impressed with the final draft of the Neighbourhood Plan. He raised one question about 'industry' in the parish and asked if the Plan was suggesting that it should not be encouraged. Cllr Sinkins responded that this was not the case – it reflected the consultation responses which had favoured small, cottage –style enterprises but not big industrial units

Jill Patterson asked if anybody had calculated the number of parish children who would need housing in the parish in the future. Cllr Sinkins responded that completely accurate figures were impossible to collate; the numbers in the Plan reflected the results gathered from the questionnaire.

Jill Patterson noted that Loving Lane was in a very bad state and needed work to repair large potholes. Cllr Jenkinson agreed to report.

Robbie Patterson noted that a drain outside his house had been cleared very promptly following his complaint to Cornwall Council.

The Clerk reported that she had contacted Keith Adams about a new licence for the Forest Field but he had informed her that he was standing down as the Chairman of Governors at Lanlivery School. She had then contacted the school direct to ask if the new Academy wished to continue using the Forest Field and, if so, would they be happy to finance a new agreement. The response had been that the school wished to continue and that it would meet the cost of the new licence, although, subject to cost, may need to get clearance from the Academy Trust.
