Police Report

There had been no recorded crime in the parish in February but 3 incidents had been recorded (public safety).

Public Questions

Ed Veerman queried why the public footpath by the Crown was still closed. He appreciated that sewage was leaking on to the path but this had been reported to Cornwall Council and the Environment Agency about a year ago and it was inexcusable that the pollution was still happening. Quite apart from the risk to human health there was also a very real risk of polluting the water courses. The Chairman confirmed that Cllr Martin had been asked to follow up the cause of the contamination and requested that he report back to the Clerk urgently. Initial tests had indicated that the source of the problem was not the Crown Inn but given that the pub was adjacent and above the leakage and the positioning of sewage pipes and septic tanks serving other properties in the area made them unlikely sources, members still considered that it was very probable that the leakage was coming from there.
