A member of the public noted that the sign for the school had still not been replaced by Cornwall Council.

Cllr Challis reported that he would need specialised accommodation shortly for health reasons as he would not be able to stay in his current farmhouse. This was the reason for the planning applications that members would be considering later in the meeting. The two additional dwellings were intended as holiday lets and would help to finance the conversions, although it was possible that his son would want to occupy one of them at some point. 21/71 Planning

- 1. PA21/07005. Conversion of agricultural barn to three dwelling units and attached art studio/workshop. Breney Farm, Lanlivery, PL30 5DF. Members discussed this application at some length and were mindful of the relevant policies in the Lanlivery NDP and, in particular, GEN2, LH1, LH1 and LRE2. It was then proposed by Cllr Sinkins, seconded Cllr Paterson and RESOLVED that a recommendation of no objection should be made to Cornwall Council, but subject to a local occupancy condition being applied to Barn 1A, consistent with the Lanlivery NDP policy LH2 (conditions 7.32 7.39), and the remaining two units also being restricted to local occupancy or holiday accommodation only.
- 2. PA21/07006. Listed building consent for conversion of agricultural barn to three dwelling units and attached art studio/workshop. Breney Farm, Lanlivery, PL30 5DF. It was proposed by Cllr Sinkins, seconded Cllr Paterson and RESOLVED that a recommendation of no objection should be made to Cornwall Council, but subject to a local occupancy condition being applied to Barn 1A, consistent with the Lanlivery NDP policy LH2 (conditions 7.32 7.39), and the remaining two units also being restricted to local occupancy or holiday accommodation only.
- 3. PA21/07690. Proposed kitchen and dining extension. Stoneycroft, Boslymon Hill, Sweetshouse, PL30 5AN. It was proposed by Cllr Paterson, seconded Cllr Sinkins and RESOLVED that a recommendation of no objection should be made to Cornwall Council.

21/72 To Receive Reports (if any) from Parish Councillors

Cllr Sinkins reported that Cormac had treated the potholes in Black Hill with their velocity machine the previous Saturday.

Cllr Wright reported that she had received another complaint about tractors and trailers using local roads inappropriately, driving too fast and with no regard for the safety of other road users. The lady would now report the matter to the police. Cllr Sinkins suggested that she should get photographs and licence numbers of the tractors involved.

Cllr Haley had received a complaint about the rough road at the top of Boslymon Hill. It was agreed that Cllr Martin should be asked to follow up again as this had already been reported.

Cllr Sinkins reported that somebody had camped again in Black Hill car park and left the unpleasant remains of their stay behind. She understood that a Luxulyan resident had cleared up the site.

Cllr Paterson was pleased to note that people were beginning to cut back their road hedges.
